



**HOWARD STERN SHOW ‘BABA BOOEY SONG’ PARODY CONTEST
ENTRY FORM, AGREEMENT, RELEASE AND ASSIGNMENT**

By submitting the recording enclosed herewith (the “Recording”) in connection with the above-referenced contest (the “Promotion”) and by signing this entry form and agreement:

1. I hereby grant to Sirius Satellite Radio Inc. (“Sirius”), Howard Stern (“Stern”), One Twelve, Inc. (“One Twelve”), Anheuser-Busch, Inc. I hereby assign to Sirius, Stern, One Twelve, Busch and their respective licensees, agents, employees, directors, affiliates, successors and assigns whatever rights or interest I may have in the Recording, my Appearance and the use of my Information in connection with either of the foregoing, including without limitation, any rights that I may have to any proceeds arising out of the production, sale, distribution or other uses of the Recording and/or my Appearance.

2. I hereby grant to iN Demand L.L.C. (“iN Demand”), its licensees, agents, employees, directors, affiliates, successors and assigns (collectively, “Other iN Demand Parties”), the perpetual, royalty-free right to use and exploit any recorded synchronized audio and video of Recording, my Appearance and my Information in connection with either of the foregoing, each whether alone and/or in conjunction with other materials, as part of its television programming and promotion thereof by iN Demand and Other iN Demand Parties (the “iN Demand Programs”). I hereby assign to iN Demand, its affiliates, successors and assigns whatever rights or interest I may have in the Recording, my Appearance and the use of my Information in connection therewith, including without limitation, any rights that I may have to any proceeds arising out of the production, sale and distribution of the Recording and/or any Appearance as part of the iN Demand Programs or programs of Other iN Demand Parties.

3. I understand and agree that the Recording, my Appearance and my Information may appear in Programming, video and other products of an adult nature, which may contain the use of vulgar language, embarrassing situations and/or nudity. I hereby acknowledge my permission for the use of my Appearance and my Information in connection therewith.

I hereby release and indemnify Sirius, Stern, Once Twelve, iN Demand, Busch and their respective representatives, licensees, agents, affiliates, successors, assigns, officers, employees, directors, shareholders and agents (collectively, the "Released Parties"), from and against any and all causes of action, demands, claims, liability, damages, losses, and costs and expenses (including without limitation legal costs and expenses) of any nature whatsoever, including without limitation, relating to copyright and/or other intellectual property rights, rights of publicity, invasion of privacy, defamation, libel, slander and other personal and property rights, which I or any member of my family have, incur or thereafter may have or incur against any of them (collectively, "Claims") arising out of or in connection with the Recording, my Appearance, my Information, my participation in the Promotion, any of my acts or statements and the use or exploitation of any of the foregoing in any media for any purpose whatsoever. I agree not to bring or participate in any such Claim against the Released Parties.

I hereby represent that (a) I am 21 years of age or older; (b) no person(s) other than the undersigned individual(s) contributed to, appears on or has any interest in the Recording; (c) I have read, understand and accept this agreement and the official rules of the Promotion (the "Official Rules"); and (d) I intend this agreement and the Official Rules to each be binding on me, my heirs, executors, administrators and assigns. By signing below, I intend to waive legal rights against Released Parties on behalf of myself, my heirs, executors, administrators and assigns.
